The funds currently on deposit with Evans Bank are secured by FDIC coverage and securities held by Manufacturers and Traders Trust Co. as custodian for Evans Bank, N.A. through Wilmington Trust. The MUNI VEST generated \$2,436.54 of interest income for the period January 1, 2017 through December 31, 2017.
