The contractor, Lawnsmith Inc., has agreed to perform the landscaping services for \$900. this year and was previously authorized by the Administrative Director.

The IDA is proceeding with the website updates with WebEssentials. We have transmitted new terminology, photos and outlines. We expect that a draft version of the new website will begin production soon. Our deposit check of \$2,200 was approved as part of the bills earlier in the meeting.

The IDA continues its efforts to assist retail growth within the Town. Phone calls and siting options are being transmitted, however the industry is very slow and we expect very little retail growth this year. The good news is that the ICSC has reported that nationally retail is rebounding with smaller footprint locations that also host consumer pickup. This has been successful in competing with the Amazon affect.
